### DIRECTIONS:

Shake well before using.

**For Metal Surfaces:** Clean surface using steel wool and wipe with good cleaning solvent if necessary. Then apply as directed.

**For Rubber Surfaces:** Clean with water and a good detergent. Wipe dry, and then apply as directed below.

**To Apply:** Hold can 8 to 10 inches from surface to be treated. Push button down to spray. Only a thin application is desired. If excess is applied, wipe off with a clean cloth.

DO NOT get product on walked-upon surfaces, they could become slippery, especially when wet.
