DESCRIPTION:

INSECT-O-FOG is an odor-free total release indoor fogger. This product seeks out bugs where they hide and kills on contact. It is water-based and is non-staining. INSECT-O-FOG kills exposed or accessible stages of these insects: ants, booklice, carpet beetles, centipedes, cockroaches, confused flour beetles, crickets, earwigs, firebrats, fleas (adult and larvae), flies, fruit flies, gnats, grasshoppers, hornets, house flies, midges, millipedes, mole crickets, mosquitoes, palmetto bugs, pill bugs, rice weevils, saw-toothed grain beetles, scorpions, silverfish, small flying moths, sow bugs, spiders, stable flies (dog flies), ticks, wasps, water bugs and yellow jackets.

DIRECTIONS:

For use in apartments, attics, basements, boats, cabins, campers, closed barns, day camps, garages, homes, horse stables, household storage areas, kennels, pet sleeping areas, rooms, greenhouses, ship cabins, bathhouses, seed houses, washrooms, and the non-food/feed areas of schools, theaters, trucks, warehouses, box cars, hospitals, hotels, industrial plants, motels, and preschools. Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms, but excluding areas where foods may be prepared or held. Nonfood areas are areas such as garbage rooms, lavatories, floor drains, entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage. DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft x 5 ft or smaller; instead, allow fog to enter from other rooms. Turn off ALL ignitions sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle on and off (i.e., refrigerators, thermostats, etc.). Call your gas utility or Management Company if you need assistance with your pilot lights. One 6 ounce aerosol can treats up to 6,000 cubic feet of unobstructed area (a room 30 ft by 25 ft with an 8 ft ceiling). For fleas and ticks, use one 6 ounce can for every 1,500 cubic feet of room space.
